NATIONAL LAND CODE

Pahang Land (amendment) (no. 4) rules 2019

in exercise of the powers conferred by section 14 of the National Land Code [Act 56 of 1965], the State Authority makes the following rules:

Citation and commencement

1. (1) These rules may be cited as the **Pahang Land (Amendment) (No. 4) Rules 2019**.

(2) These Rules shall come into operation on 1 January 2020.

Substitution of rule 22
